**SUBJECT: PAYMENT MANAGEMENT SYSTEM SUB-ACCOUNT CODES FOR
WORKFORCE INVESTMENT ACT SECTION 166 INDIAN AND
NATIVE AMERICAN SUPPLEMENTAL YOUTH SERVICES AND
COMPREHENSIVE SERVICES GRANT FUNDS**

1. **Purpose.** To provide grantees with updated information on the Payment Management System (PMS) subaccounts for Program Year (PY) 2005 funds.
2. **References.** Division of Indian and Native American Programs (DINAP) Bulletin No. 98-27; A Guide to Smartlink II, Enclosure (1), Subaccount Structure and PY and Title Codes.
3. **Background.** Workforce Investment Act (WIA) Section 166 grantees will be issued new signed grant documents authorizing them to operate Comprehensive Services and, if eligible, Supplemental Youth Services Programs during PY 2005. Grantees that use the PMS to draw down their WIA funds should reference Attachment I, which provides the structure of the nine-digit PMS subaccount code structure. Grantees who continue to obtain their funds through the SF-270, Request for Advance or Reimbursement, will not be affected by this guidance.
4. **Action.** The subaccount code required to access Section 166, WIA Supplemental Youth Services funds for PY 2004 is **QZ**. The subaccount code for PY 2005, Section 166 Comprehensive Services funds is **RT**. WIA Section 166 grantees should use these subaccount codes to draw down PY 2005 funds.
5. **Important Reminder.** All previously-issued subaccount codes remain the same. Grantees are reminded that, when drawing down funds under the WIA Section 166 fund appropriations, the oldest remaining funds should be drawn down first. Therefore, PY 2004 subaccounts (OA and OX) should be "zeroed out" prior to drawing down on the PY 2005 subaccounts.
