**SUBJECT:** Native American Employment and Training Council Call  
 for Nominations

- 1. Purpose.** To request Workforce Investment Act (WIA) Section 166 grantees to submit nominations for consideration by the Secretary of Labor for appointment to fill expiring terms of membership on the Native American Employment and Training Council (Council).
- 2. Reference.** WIA Section 166 (h)(4) and 41 CFR §102-3.30 (c)
- 3. Background.** The current Council Charter was renewed for two years, effective June 24, 2005. The charter provides for approximately twenty-one members appointed for two years by the Secretary of Labor. Appointments for the following nine members will expire on October 14, 2007:

In reference to the "Other Discipline" memberships, the Federal Advisory Committee Act regulations (41 CFR), at §102-3.30 (c), require advisory committees to have a balanced membership, regarding points-of-view represented and the functions to be performed. Factors to be considered in achieving such a membership include the committee's mission and the geographic, ethnic, social, economic, or scientific impact of the committee's recommendations. Perspectives may be those of consumers, technical experts, the public at-large, academia, or business or other sectors.

Within this framework, and in addition to the regional representation, it is permissible for the composition of the Council to include individuals with certain expertise to assist in accomplishing its mission. These individuals, as are all members of the Council, must be representatives of Indian Tribes, Tribal organizations, Alaska Native entities, Indian-controlled organizations serving Indians, or Native Hawaiian organizations. In nominating Other Discipline representatives, the factors described above must be considered.

4. **Action.** The Secretary of Labor may consider nominations for appointment to the Council as submitted by the grantee communities. All members listed above are still eligible for nomination. All nominations must be submitted (**U.S. Postmarked or electronically dated**

**(e-mail)** no later than forty-five calendar days, excluding any Federal holidays, from the date of this guidance. Submit Council nominations on the attached form. Nominations may also be sent by commercial carrier to the above address.

Grantee (including those designated as Public Law 102-477) representatives in Regions I, III, and Hawaii may submit nominations for expiring memberships in their areas only.

Indian tribes and Indian, Alaskan Native, and Native Hawaiian organizations that do not administer a Section 166 grant may submit nominations. Public Law 102-477 grantee representatives are eligible for appointment to the Council. Self-nominations will be accepted.

In submitting nominations, consider the availability of the nominee to attend and actively participate in Council meetings (a minimum of two meetings annually), serve on Council workgroups, and provide feedback to the grantee community. Communication between the Council member and his or her constituency is essential to the partnership between the Employment and Training Administration and the Indian and Native American community.
