**SUBJECT:** Fiscal Year (FY) 2006 Unemployment Insurance Benefits Timeliness and

Quality (BTQ) Nonmonetary Determination Evaluation Training Seminars

- **1.** <u>Purpose</u>. To announce additions to the schedule for FY 2006 BTQ Nonmonetary Determination Evaluation Training Seminars.
- **2. References.** ET Handbook No. 301, Fifth Edition, Revised July 2005.
- 3. <u>Background</u>. To maintain a cadre of state staff trained in the quarterly nonmonetary adjudication quality review process, the U.S. Department of Labor (USDOL) offers training seminars annually at various locations across the country. This training prepares nonmonetary determination adjudicators to participate in the quarterly tripartite quality reviews and Benefits Accuracy Measurement (BAM) / Denials Accuracy Measurement staff to accurately investigate and assess the quality of nonmonetary determinations.
- **4. FY 2006 BTQ Nonmonetary Determination Evaluation Training Seminars.** The following sessions, each for approximately 25 participants, are planned:

**5.** <u>State Nominees.</u> Nominations for each session will be accepted on a first-come, first-served basis. State workforce agencies (SWAs) may nominate potential participants for either session. Therefore, nominations should indicate the applicable session.

Although this training is designed to prepare nonmonetary determination adjudicators to participate in the quarterly tripartite reviews, it is also useful for other nonmonetary determination adjudicators and BAM investigative staff.

- **6.** <u>Logistics.</u> Travel arrangements and costs for attendees are the responsibility of the nominee's employing agency. Specific information regarding hotel reservations and locations is attached. Persons with disabilities who wish to attend should send requests for accommodation to the appropriate Regional Office (RO).
- 7. <u>Action Required</u>. State Administrators are requested to notify appropriate SWA staff of the upcoming BTQ Nonmonetary Determination Evaluation Training Seminar and provide RO staff with the name(s) of each SWA nominee and session requested. Nominations should be submitted to the RO no later than August 11, 2006, for the session in Washington D.C. and no later than August 18, 2006, for the session in Charleston, South Carolina.
